Rita's work accomplishments are truly exemplary. However, what distinguishes her from others and what truly makes her an exceptional POP officer is her incredible level of compassion for others. Rita cares for all the people in the community. If someone is hurt, injured or bullied Rita is the first to console the victim and she is the first to discipline or arrest the offender. The stickers were in chronological numerical order, raising suspicion. POP Officer McCaffrey reached out to a senior investigator at DMV and information on the stickers was obtained. Future investigation is warranted. POP conducted an investigation and issued several parking tickets. The subject then filed a complaint with the 7TH Precinct supervisor. Sgt. Howell conducted an investigation and found no dereliction of duty. The subject has since complied and moved the trailer.
